

**NOTICE OF A PUBLIC MEETING

RECEIPT OF COMPLETE APPLICATION

TAKE NOTICE that the Township of Perry has received a complete application to amend Municipal Zoning By-law 2002-10. The application affects a rural property located at 168 Old Monteith Road, located in Lot 30, Concession 11 in the Township of Perry (see attached Key Map). The purpose of the rezoning is permit a portion of the subject lands to be used as an outfitter's storage and staging area.

TAKE NOTICE that the Council for The Corporation of the Township of Perry will be holding a public meeting under Section 34 of the Planning Act, R.S.O. 1990, c.P. 13 as amended, to allow the public to comment on this application for a proposed Zoning By-law Amendment.

DETAILS OF THE ZONING BY-LAW AMENDMENTS

The purpose of the proposed By-law is to amend the Restricted Area (Zoning) By-Law No. 2002-10 as amended, to lands located at 168 Old Monteith Road located in Lot 30, Concession 11.

The application, if approved, would rezone a portion of the lot from the Rural (RU) Zone to a Rural Exception (RU-16) Zone to permit a portion of the subject lands to be used as an outfitters storage and staging area. The proposed use comprises a storage and accommodation facility for groups of 10 to 20 people as well as an accessory washroom/shower building. The facilities would be utilized by an outfitter co-operative that co-ordinates group excursions to Algonquin Park.

Additional information relating to this application including a draft site plan is available at the Township of Perry Municipal Office for public review during regular office hours.

ADDITIONAL INFORMATION AND MAP OF LAND SUBJECT TO THE APPLICATION

A key map showing the land to which the proposed amendment applies is provided on this notice.

The purpose of this meeting is to ensure that sufficient information is made available to enable the public to generally understand the applicant's proposed Zoning By-law Amendment. Any person who attends the meeting shall be afforded an opportunity to make representations in respect of the applications.

If a person or public body does not make oral submissions at a public meeting or make written submissions to Council before the proposed By-law is approved, the person or public body is not entitled to appeal the decision of Planning Board to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting or make written submissions to Council before the proposed By-law is approved, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

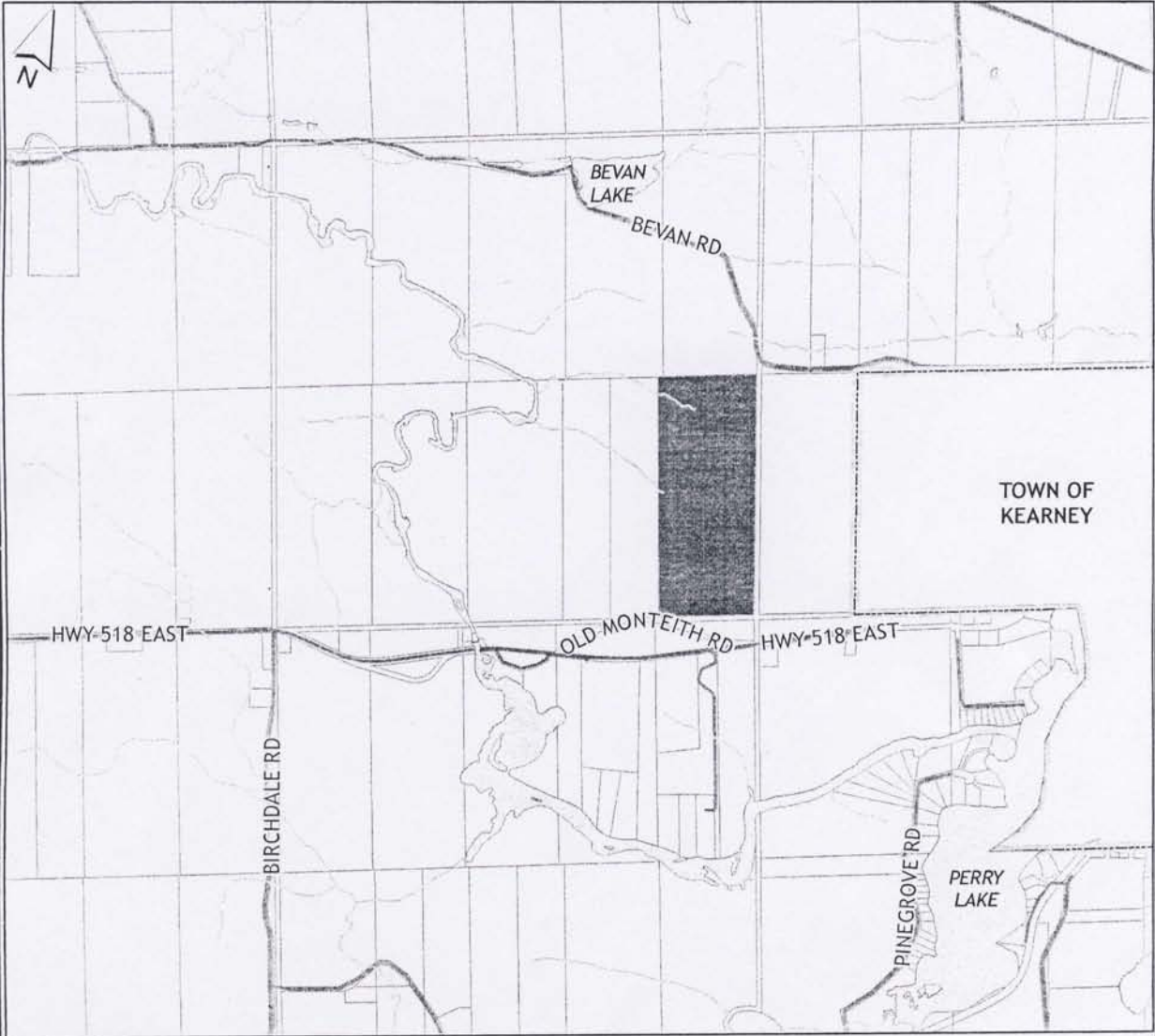
