

The Corporation of the Township of Perry
By-law #2006-04

Being a By-law to Establish the Fees and Charges
For Various Services Provided by the Municipality

WHEREAS pursuant to Section 391 of the Municipal Act, SO 2001, c. 25, as amended, a Council of a municipality may pass by-laws imposing fees or charges for services or activities provided or done by or performed on behalf of it;

NOW THEREFORE the Council of the Corporation of the Township of Perry enacts as follows:


1. The fees and charges for various municipal services be established as shown in the Schedules attached hereto and forming part of this By-law:

Schedule 'A'- Administrative Department
Schedule 'B'- Public Works Department
Schedule 'C'- Miscellaneous Fees and Charges


2. The fees and charges set forth in each of the schedules attached hereto shall come into effect on the date of which this by-law receives third and final reading and is enacted in Open Council.
3. This By-law shall be known as the "Various Fees and Charges By-law"
4. Should any part of this By-law, including any part of the schedules attached hereto be determined by a Court of competent jurisdiction to be invalid or of no force and effect, it is the stated intention of Council that such invalid part of the By-law shall be severable and that the remainder of this By-law, including the remainder of the schedules attached hereto, as applicable, shall continue to operate and to be in force and effect.
